THE CONSTITUTION OF THE UNITED REPUBLIC OF TANZANIA (CONSTITUTIENCIES  
AND POLLING DISTRICTS) NOTICE 2015

WHEREAS in pursuance with the provisions of Article 74(6)(c) of the Constitution of the United Republic of Tanzania of 1977, Cap.2, the National Electoral Commission is empowered to review the boundaries and demarcate the United Republic into various areas for the purposes of Parliamentary Elections;

AND WHEREAS in pursuance of the provision of section 5(1) of the National Elections Act, Cap. 343 the National Electoral Commission is empowered to divide every constituency into polling districts;

NOW THEREFORE, in the exercise of the powers conferred upon the National Electoral Commission by Article 74(6) of the Constitution of United Republic of Tanzania of 1977, Cap.2 read together with section 5(1) of the National Elections Act. Cap.343 the National Electoral Commission, hereby issue the following Notice.

**Citation and commencement**

1. This Notice may be cited as the Constitution of the United Republic of Tanzania (Constituencies and Polling Districts) Notice, 2015 and shall come into force on the next day following the date on which the National Assembly is dissolved.

**Application**

2. This Notice shall apply, for the purposes of the conduct of Presidential and Parliamentary Elections in year 2015, in the United Republic of Tanzania.

**Polling district to compose**

3. A constituency shall be composed of one or more

4. –(1) There shall be constituencies and polling districts as specified in the Schedule to this Notice.

(2) For the purposes of this Notice, the boundaries of polling districts in Tanzania Zanzibar shall be within various Shehia established by the Minister responsible for regional administrative and local government of the Revolutionary Government of Zanzibar.

5. Subject to Article 75(5) of the Constitution of the United Republic of Tanzania, 1977 and paragraph 2 of this Notice, the constituencies and polling districts under this Notice shall subsist from the date of dissolution of the National Assembly and for the whole period of lifespan of the National Assembly following the conduct of the 2015 General Elections.
